ECMC Staff was performing a follow-up inspection to a complaint at an adjacent tank battery (Location #306751) south of WCR54 and identified a PDC meter shed that indicated it went to the Hankins tank battery (Location #331006). Both locations are now closed and the meter shed needs to be removed in order to comply with Rule 1004. The last well (API #123-19993) was PA'd on 09/25/2023; all surface equipment should have been removed within 3 months of plugging the well (12/25/2023). This inspection report is being entered in addition to the most recent FIR (doc #708201642) for Location (#331006). Refer to the attached inspection photos.
