Location pad and equipment (meter house, bollards, fencing) remained, the location has yet to be recontoured, graded or deep ripped. Surrounding the location were large populations of scotch thistle and common mullein that once final reclamation activities have begun will need to be managed. Reclamation rules require reclamation activities to be conducted within twelve months of plugging on non-cropland. Well was plugged 11/29/2023, therefore final reclamation must be completed by 11/29/2024.</p>		Date _____
