Elevated EC was observed in multiple characterization samples used to delineate the magnitude and extent of elevated EC but was not deemed attributable to native soil conditions by the ECMC. Per the COA provided on Doc. #402640641 the Operator will submit a detailed reclamation plan pursuant to Rule 915.b and will request NFA designation be granted with elevated inorganics left in situ.
