**General Comment:****ECMC Inspection Report Summary**

On Tuesday 10/15/2024, I, Inspector Scott Ramsey, conducted a routine inspection at Caerus Marathon 13C, at Location # 335857 in Garfield county Colorado.

Any Corrective Actions from previous Inspections that have not been addressed are still applicable.

While there, I observed normal production operations. This location is within or in close proximity to a CPW Density/High Priority Habitat, black bear, NSO habitat, Wildlife Management Area. Operator (Caerus) has provided documentation of their Best Management Practices for Sediment Tracking Controls.

During this inspection the following compliance issues were observed:

1. Random debris
  2. Missing cap/plug on tank
  3. Well signage lacking information
  4. Lack of battery signage
