Soil samples were analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, and boron. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

Five background samples will be collected from an area not impacted by oil and gas development at similar depths and lithologies as confirmation samples collected at the location and analyzed for ECMC Table 915-1 metals only since elevated concentrations of soil suitability for reclamation standards (pH, EC, SAR, and Boron) were not observed in the initial confirmation samples collected during the site's decommissioning. The samples will be used to characterize native soil and potentially attribute elevated metals to native soil conditions.
