Tumbleweeds are a troublesome annual non-native weed that easily breaks off at the stem. Operator failed to control and manage weeds to prevent weed waste and prevent the spread of seeds onto adjacent lands.

As a note to the Operator, once the wells have been plugged and the location is undergoing final reclamation the Operator shall remove all rock/gravel berms that were associated with the well location for irrigation purposes.
