It was observed in this inspection that stormwater BMPs installed are inadequate and stormwater issue persist on location. Original CA has not been addressed. Original CA and date remains applicable. No CA date is being provided as this location is out of compliance for the same Rule.

Additionally - Eastern cut slope remains with bare soils and active rill erosion.
