A site investigation was conducted pursuant to ECMC Rule 911 at the WALKER T4N-R65W-S4 L01 Tank Battery location.

Seven (7) grab confirmation soil samples will be collected from the produced water vessel excavation (5), beneath the above-ground oil tank (1), and at the separator (1). Soil samples were analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil per ECMC Table 915-1, EC, SAR, pH, and boron. Five (5) samples were submitted for waste characterization of ECMC Table 915-1 metals. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

A background sample for pH, and ECMC Table 915-1 metals analysis was collected. Residual metals do not exceed applicable regulatory limits and/or background comparison/local "clean-up level" (see arsenic). Inorganic parameters in groundwater observed in up-gradient, unimpacted monitoring well MW-06 were used in the determination of "local background levels" at the site. Concentrations of chloride and sulfate anions and total dissolved solids (TDS) are less than/consistent with local background levels.

A site assessment will be scheduled to delineate impacted media observed at the site. Noble proposes soil samples will be collected for analysis of the Table 915-1 TPH (C6-C36) and organics in soil. Residual metals and pH at the site do not appear attributable to the release. If groundwater is encountered each soil boring will be completed as a monitoring well and the groundwater will be sampled for BTEX, naphthalene, 1,2,4-trimethylbenzene, 1,3,5-trimethylbenzene, 1-methylnaphthalene, 2-methylnaphthalene, and inorganic parameters.

SOURCE REMOVAL SUMMARY

A subsurface assessment was conducted to delineate residual impacts at the site. Upon encountering groundwater, eight (8) soil borings were completed as monitoring wells. Soil samples were collected for analysis of ECMC Table 915-1 TPH (C6-C36) and organics in soil in accordance with approved Form 27 Doc. # 403259972. Residual metals and pH at the site do not appear attributable to the release.

REMEDIATION SUMMARY

Describe how remediation of existing impacts to soil and groundwater is to be accomplished (i.e. summarize remedial action plan). Provide a brief narrative description including: technical justification, schedule for implementation, estimated time to attain NFA status, plus plans and specifications for the selected remedial action technology.

A subsurface assessment was conducted to delineate residual impacts at the site. Eight (8) soil borings were completed as monitoring wells. Analytical results identified residual petroleum hydrocarbon impacts in soil collected from MW-01. Monitoring wells will continue to be sampled on a quarterly basis to monitor natural attenuation of dissolved impacts. Additional remediation strategies may be proposed in a supplemental Form 27 as applicable.

NFA status will be considered when soil is in compliance with ECMC Table 915-1 regulatory limits and a minimum of four (4) quarters of groundwater analytical results are in compliance with ECMC Table 915-1 regulatory limits.

Noble seeks the ECMC's approval of this form as they are aware of the gap in reporting from the the December 2021 groundwater sampling event until now. Groundwater monitoring reports for 2022 are attached to current submittal. Following the review by the ECMC, Noble will complete 90-day reporting to comply with current ECMC regulations.
