A site investigation was conducted pursuant to ECMC Rule 911 at the EMMY STATE H25-14-A T3N-R65W-S25 L01 Facility around the area of the Partially Buried Vessel (PBV) being removed.

On 04/03/2024, grab confirmation soil samples were collected from the base of the PBV excavation (FS01@4') and sidewall (SS03@3'). Soil samples were analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil per ECMC Table 915-1, EC, SAR, pH, boron, and metals in soil per ECMC Table 915-1. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

The implementation schedule has been changed due to the decommissioning of the Emmy State H25-14A Econode PBV and necessity for SSI activities adjacent to the PBV. The proposed site investigation will be completed following the approval of this form, landowner negotiations, and crew availability.

OPERATOR COMMENT

This Form 27 is being submitted as a Third Quarter Timeline Update for the completion of a SSI at the former Emmy State H25-14A Econode Vault location. The SSI will be completed in accordance with the Site Investigation Report section of this Form 27, and the attached proposed soil boring map.

Based on the contaminants of concern identified during decommissioning, Noble proposes to limit future soil sampling to pH. Concurrent with delineation activities, additional background samples will be collected to determine if pH and arsenic observed at this location are indicative of native material conditions.

Quarterly reporting will be conducted until closure criteria are achieved for the remediation project. The results of the supplemental site investigation will be submitted on a subsequent Form 27.
