On Monday, 01/13/2024, Inspector Kirby Burchett, conducted a follow up inspection at KT Resources LLC on the WRD Federal 19-31 well, Location #316279, in Rio Blanco County, Colorado.

This location is within or in close proximity to a Parks and Wildlife (CPW) District and Black Bear area with High Priority, NSO, Density and Other Consultation Habitat regulations.

Any Corrective Actions from previous Inspections are still applicable.

Follow up inspection in response to compliance issues observed during Insp. #715500496 on 7/31/24 and 3 previous inspections dating back to 4/13/23. The following Corrective Actions are unresolved and original due dates remain:

1. Sediment migration and erosion migration from location.
2. Oily waste and stained soil inside tank battery.
3. Gas meter calibration out of compliance.
4. Weeds.
5. Illegible labels.

Refer to Inspection Photos for observed compliance issues.

A follow up on this site inspection will be conducted to ensure all compliance issues have been corrected to comply with ECMC rules.
