A site investigation was conducted pursuant to ECMC Rule 911 at the KILDOW PM C31-8, TIMKO C31-17, 22 Tank Battery location.

Grab confirmation soil samples were collected from the produced water vessel(s) excavation, beneath the ground oil tank(s), and at the separator(s). Soil samples were analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, and boron. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

The AST02@6.0" sample location will be resampled to confirm the concentration of pH outside the Table 915-1 concentration range. If analysis of the resampled soil is within the Table 915-1 standard range for pH the operator proposes to use the sample in place of the initial sample in consideration for site closure at the time of an NFA request. If analysis of the resampled soil remains outside the Table 915-1 pH range a minimum of four additional soil borings will be advanced to define the magnitude and extent of pH outside the Table 915-1 pH range.

Impacted soil will be removed from the release area at the 31-4-64 SENE Tank Battery location by excavation. The impacted soil will be disposed of at an approved landfill as non-hazardous waste in accordance with Rules 905 and 906. Copies of the waste manifests will be available upon request.

Excavation of impacted soil will be undertaken to remove impacts observed 4.5 feet below ground surface at and adjacent to the SEP01@4.5' 31-4-64 SENE Tank Battery location. Confirmation soil samples will be collected and analyzed for ECMC Table 915 organic and Soil Suitability for Reclamation constituents (TPH, BTEX, 1,2,4 Trimethylbenzene, 1,3,5 Trimethylbenzene, Naphthalene, Polycyclic Aromatic Hydrocarbons [PAHs], pH, SAR, EC, and Boron) and ECMC Table 915-1 metals.

Should no additional active remediation be required following source removal at the location, a no further action (NFA) determination will be requested within 90 days following laboratory confirmation of the removal of impacted soils with respect to the applicable Table 915-1 screening levels at the site. If groundwater impacts are observed, an NFA will be requested once four consecutive quarters of groundwater sampling have been completed and reported at the location with concentrations of Table 915 constituents below regulatory limits.
