**INITIAL ACTION SUMMARY**

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECMC Rule 911 a site investigation will be conducted pertaining to the SHABLE USX AB11-11P wellhead cut and cap and flowline removal. Approximately 2118' of flowline will be removed, however a portion of the flowline will be abandoned-in-place due to field constraints. The ECMC will be updated in a supplemental Form 27. The wellhead will be cut and capped per ECMC rules. Additionally, soil samples will be field screened at the N-E-S-W sides of the wellhead. So as to not disturb the area of field constraint, soil samples will be taken at the start and endpoint of the flowline where the area exists. Soil samples will also be taken along the flowline any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway. The Flowline Pre-Abandonment Notice Document number was previously included under Related Forms.

Grab confirmation soil samples were collected along the flowline at any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway, AS APPLICABLE to abandonment type. Soil samples were analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, and boron. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods. A grab confirmation soil sample will be collected at the wellhead excavation in base of the excavation or the area showing the highest degree of impact during

Sixteen background samples were collected from an area not impacted by oil and gas development at similar depths and lithologies as confirmation samples collected at the Shable USX AB 11-14P location and analyzed for ECOM Table 915-1 metals and soil suitability for reclamation standards (pH, EC, SAR, and Boron). Ten samples exceeded the Table 915-1 standards for pH, two samples exceeded for SAR, one sample exceeded for EC, 20 samples failed for As, 14 samples failed for Ba, six samples failed for Cd, seven samples failed for Pb, 10 samples failed for Se.

Impacted soil will be removed from the release area at the Shable USX AB 11-11P location by excavation. The impacted soil will be disposed of at an approved landfill as non-hazardous waste in accordance with Rules 905 and 906. Copies of the waste manifests will be available upon request.

### REMEDIAL SUMMARY

Describe how remediation of existing impacts to soil and groundwater is to be accomplished (i.e. summarize remedial action plan). Before excavation of impacted soil, soil borings will be installed to delineate the vertical and lateral extent of soil impacts at the location. Confirmation soil samples will be collected and analyzed for the full Table 915 suite. If groundwater is encountered, the soil boring(s) will be improved with temporary PVC monitoring wells and sampled for Table 915 constituents in groundwater. Should no additional active remediation be required following source removal at the location, a no further action (NFA) determination will be requested within 90 days following laboratory confirmation of the removal of impacted soils with respect to the applicable Table 915-1 screening levels at the site. If groundwater impacts are observed, an NFA will be requested once four consecutive quarters of groundwater sampling have been completed and reported at the location with concentrations of Table 915 constituents below regulatory limits. As needed, soil and/or groundwater remediation plans will be developed and submitted to ECMC in a supplemental Form 27.
