Soil sampling was conducted on 10/23/2024. Analytical Results show EC, SAR and Arsenic above Table 915-1; background samples indicate that the local levels are; EC (10.3), SAR (20.8), pH (8.54), and the Arsenic Local Clean-Up Level is 13.125 mg/kg (1.25x10.5 mg/kg). Soil Sample SP17 exceeds for Boron. Excavation has not yet been conducted.
