As part of an internal interim reclamation audit required by ECMC Reclamation Unit, this location was reported as being out of compliance with portions of Rule 1003.

ECMC, Chris Binschus, and NGL representative, Brett Forkner, discussed the compliance issues on February 11, 2025. ECMC agrees that the east and south sides do not need to be re-contoured. However, the topsoil stockpile along the eastern location is not in compliance with Rule 1002.c. Operator plans to reseed and re-contour the stockpile this Spring 2025 and will perform a vegetation assessment this Spring 2025 to determine if additional reclamation is required.
