Comment:

After reviewing the Operator supplied drone imagery, it does not appear that the location meets vegetative requirements based off of the drone documentation. Crop appears to be impacted along the former access road and flowline paths with impacted (e.g discolored) vegetation that is not reflective of the adjacent reference areas. It is uncertain if crop is impacted due to flowline abandonment in place as reported on Form 44 (doc #403906917) or other reclamation related activities. Operator will need to comply with the 900 and 1000 series rules to conduct further site investigation into soil suitability and reclamation activities to determine root cause of impact to crops. Refer to attached inspection photos for additional information.
