Comment: It does not appear that perennial vegetation is progressing and additional seeding will need to be performed before the upcoming growing season. Interseeding or broadcast seeding should be performed to limit disturbance of any desirable vegetation. Ongoing mowing should be performed throughout the growing season to prevent competitive weed growth. Continue to monitor and maintain the location until the final reclamation requirements are achieved.
