**INITIAL ACTION SUMMARY**

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECMC Rule 911 a site investigation was conducted pertaining to the JULIE C21-25 wellhead cut and cap and flowline abandonment. Approximately 1779' of flowline was abandoned-in-place. The ECMC will be updated in a supplemental Form 27 if a portion of the flowline is able to be removed. The wellhead was cut and capped per ECMC rules. Additionally, soil samples were field screened at the N-E-S-W sides of the wellhead. Soil samples were collected at the endpoints of the flowline so as not to disturb crop land. The flowline is currently planned for future removal, at which time soil sampling and screening samples will be taken along the flowline at any points of material change and/or hammer unions, and directional changes.

**PROPOSED SAMPLING PLAN****Proposed Soil Sampling**

A grab soil sample was collected at the base of the excavation or the area showing the highest degree of impact during field screening activities at the wellhead excavation. Additionally, soil samples were field screened at the N-E-S-W sides of the wellhead. Soil samples were collected at the endpoints of the flowline so as not to disturb crop land. The flowline is currently planned for future removal, at which time soil sampling and screening samples will be taken along the flowline at any points of material change and/or hammer unions, and directional changes. Soil samples were analyzed by a certified laboratory for the full extent of Table 915-1, including but not limited to: TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, metals, and boron. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

One background soil sample (BKG01) was collected near the flowline and analyzed for metals in soil per ECMC 915-1, pH, SAR, and EC. The background soil sample was collected from a depth of 3 feet below ground surface (ft. bgs). The maximum background concentrations with a 1.25x multiplier applied for arsenic, was calculated to be 3.85 mg/kg. All arsenic concentrations observed during decommissioning were below background levels. As such, arsenic should not be considered a contaminant of concern.

The SSI will be completed in accordance with the proposed implementation schedule, and the results of the SSI will be submitted on a subsequent Form 27. The flowline is currently planned for future removal, at which time soil sampling and screening samples will be taken along the flowline at any points of material change and/or hammer unions, and directional changes. Pursuant to the flowline removal, all laboratory analytical samples will be analyzed for full ECMC Table 915-1 contaminants of concern. Additional SSI activities will be proposed (as applicable) on a future Form 27 if further investigation is required.

Basis for change in implementation schedule:

The implementation schedule has been changed due to the decommissioning of the Julie C21-25 wellhead and flowline and necessity for supplemental site investigation activities adjacent to the wellhead and flowline. The proposed site investigation will be completed following the approval of this form, landowner negotiations, and crew availability.

## OPERATOR COMMENT

This Form 27 is being submitted to include the decommissioning results at the former Julie C21-15 wellhead and flowline location. A supplemental site investigation (SSI) will be completed to collect additional background samples to evaluate the barium, lead, selenium, and pH exceedances observed at FL01R-W@3', FL01R-S@3', and FLR01@4' during decommissioning, in accordance with the attached proposed site investigation map, and proposed sampling plan outlined in the Site Investigation Report section of this Form 27.

One background soil sample (BKG01) was collected near the flowline and analyzed for metals in soil per ECMC 915-1, pH, SAR, and EC. The background soil sample was collected from a depth of 3 feet below ground surface (ft. bgs). The maximum background concentrations with a 1.25x multiplier applied for arsenic, was calculated to be 3.85 mg/kg. All arsenic concentrations observed during decommissioning were below background levels. As such, arsenic should not be considered a contaminant of concern.

Based on the contaminants of concern identified during decommissioning, Noble proposes to limit future soil sampling to barium, lead, selenium, and pH. Additional background samples will be collected to determine if barium, lead, selenium, and pH observed at this location are indicative of native material conditions.

The flowline is currently planned for future removal, at which time soil sampling and screening samples will be taken along the flowline at any points of material change and/or hammer unions, and directional changes. Pursuant to the flowline removal, all laboratory analytical samples will be analyzed for full ECMC Table 915-1 contaminants of concern. Additional SSI activities will be proposed (as applicable) on a future Form 27 if further investigation is required. Quarterly reporting will be conducted until closure criteria are achieved for the remediation project. The results of the supplemental site investigation will be submitted on a subsequent Form 27.
