The source was a failed dumphine which was replaced with upgraded material. SVE system is in place to routinely operate. Regular maintenance and routine system checks implemented.

REMEDIATION SUMMARY

Describe how remediation of existing impacts to soil and groundwater is to be accomplished (i.e. summarize remedial action plan). To date, 488 cubic yards of impacted material excavated from grade to 20 ft below ground surface has been transported to Greenleaf Environmental Services for offsite disposal. Manifests will be supplied upon request.

On 5/26/2022, a battery operated (charged via solar panels) soil vapor extraction blower was plumbed into a two inch well identified by SVE-01 advanced through the impacted area directly beneath the point of release and activated.

As of December 2024, routine O&M checks in place to allow changes to be made to best suite the sites specific needs. See attached the latest field summary, performance table, and lab analytical.
