Comment: **After reviewing the Operator supplied drone imagery, it does not appear that the access road has been reclaimed. Drone closure report documentation did not include the entire access road, including the entrance off of WCR 74. Historic aerial imagery shows that an access road/entrance did not exist prior to the subject well (API 123-28147) being spud on 10/24/2010. Additional reclamation activities are required to reclaim the access road. Refer to attached inspection photos.**
