6-1-73 (Con't.) 60' above the Cherokee Shale, slight show free oil, scat light stain, small vuggy oocastic porosity, faint quick odor.

6-4-73 Atoka 5040 (- 717). From 5063 to 5068 had slight show scattered, faint stain, very fine crystalline dolomite. Morrow Shale 5211 (- 888) -143 to #1-24 C. No sand developments. Keyes Lime 5330 (-1007) -140 to #1-24 C. St. Louis 5382 (-1059) -142 to #1-24 C. 5397 to 5402 dolomite in St. Louis very fine crystalline, scattered faint stain, no free oil. Spergen 5470 (-1147) -155 to #1-24 C, -85 to #1 Carey-Hiss, -28 to Cardinals 1st well, +36 to Cardinals 2nd well. TD 5515, D&A, No logs.  
(No porosity in Spergen)

15 sxs btm of surface pipe (316), solid bridge capped with 10 sxs, 2 sxs in rat hole. Plugging completed @ 9:45 AM 6-4-73.
