Pursuant to ECMC Rule 911 a site investigation will be conducted pertaining to the DILLARD USX AB29-17 wellhead cut and cap. The wellhead will be cut and capped per ECMC rules. Additionally, soil samples will be field screened at the N-E-S-W sides of the wellhead. The flowline was previously abandoned on 12/06/2018 , and the ECMC was notified on Form 44 Document number 403216829.

Previously, one (1) grab soil sample was collected at the wellhead excavation. The soil sample was analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil per ECMC Table 915-1, EC, SAR, pH, and boron.

Previously, a background sample was collected near the wellhead and analyzed for EC, SAR, pH, boron and full ECMC Table 915-1 metals analysis. The residual arsenic concentration is consistent with background levels and does not appear to warrant additional sampling.

Additional background samples (3+) will be collected from soil of similar lithologic material not impacted by oil and gas activity and analyzed for ECMC Table 915-1 metals to further compare residual barium found at the wellhead.
