INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECOM Rule 911 a site investigation was conducted pertaining to the AMEN PC D06-18D wellhead cut and cap and flowline removed. The wellhead was cut and capped per ECOM rules. Approximately 263' of flowline was removed.

Previously: Two (2) grab soil samples were collected at the wellhead excavation (1) and the flowline terminus at the wellhead (1). One (1) grab soil sample was collected at the flowline terminus at the separator during the facility decommissioning assessment and was reported under Rem. # 26959 (Form 27 Document Number 403658963). Soil samples were analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil per ECOM Table 915-1, EC, SAR, pH, and boron. One (1) sample was analyzed for ECOM Table 915-1 metals. All samples collected were analyzed by a certified laboratory using approved ECOM laboratory analysis methods.
