A site investigation will be conducted pursuant to ECMC Rule 911 at the PALOMINO FED T8N-R59W-S13 L01 Facility and Tank Battery location. Noble will conduct field screening during dumphine removal (separators to tank battery) and include field screening results, along with photo documentation, on a Form 27 Supplemental.

Grab confirmation soil samples will be collected from the produced water vessel(s) excavation, beneath the ground oil tank(s), and at the risers for the flowline(s) and dumphine(s) of any separator(s). Noble shall collect confirmation soil samples as described in the Rule 915.e.(2). Soil samples will be analyzed by a certified laboratory for the full extent of Table 915-1, including but not limited to: TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, metals, and boron. All samples collected will be analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

In response to the COA provided 3/7/2025 on returned to draft document number 403994286: Remedial actions and reporting for this project (FEDERAL PALOMINO-68N59W 13NESW, Remediation Number 30320) pertain to decommissioning activities performed at the tank battery only. The Operator has previously reported and will continue to report all remedial activities related to the associated Federal Palomino 11-13 flowline under Remediation Number 30346.

A secured analytical data report is pending for the decommissioning activities conducted at the FEDERAL PALOMINO-68N59W 13NESW, Remediation Number 30320. Upon receipt of a secured report, analytical findings will be summarized and provided. SF27s will continue to be submitted on a quarterly basis until closure criteria are achieved.
