INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECMC Rule 911 a site investigation was conducted pertaining to the IRVINE 2-11 wellhead cut and cap and flowline removal. The wellhead was cut and capped per ECMC rules. Approximately 555' of flowline was abandoned in place. The ECMC will be updated with a Form 44 Document Number on a Supplemental Form 27.

Previously, two (2) grab soil samples were collected at the wellhead excavation (1) and flowline terminus at the separator (1). Additionally, soil samples were field screened at the N-E-S-W sides of the wellhead. Soil samples were analyzed by a certified laboratory for the full extent of Table 915-1, including: TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil per ECMC Table 915-1, EC, SAR, pH, metals, and boron. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

Previously, a background sample was collected off-pad from similar lithographic soil near the wellhead for arsenic analysis. A second background sample was collected near the flowline terminus at the separator for EC, SAR, pH, boron, and ECMC Table 915-1 metals analysis. In the absence of organic, inorganic, and other metal concentrations exceeding ECMC regulatory limits, the residual arsenic concentration is not indicative of an E&P release and is consistent with current background comparison.
