Comment: This location does not comply with Rule 1004. During this inspection, it was observed that the former well location does not appear to be progressing towards reclamation standards or regulations. Debris (e.g. concrete, metal, ect) and road base remain throughout the former access road and well location. The former well location does not meet vegetative standards with evidence of non-uniform vegetation cover resulting in areas of bare soils. Additional reclamation activities are required. Refer to attached inspection photos.

Reseed disturbance areas using a seed mixture requested by the surface owner, or a mixture prescribed by the local county NRCS. Establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of reference area levels. Ensure erosion controls are implemented to stabilize the seeded soil. Operator shall continue to monitor and manage this site until the location meets Rule 1004 standards, including stormwater and weed management.</div>	Date _____
