Comment:

This location remains in process due to insufficient vegetation cover. Continue to monitor and manage this site until the location meets Rule 1004 standards, including stormwater and weed management.

The access road appears to have been recently reclaimed, with evidence of drill row seeding and straw mulching.

Reference area conditions are degraded with bare ground and bindweed vegetation growth. The reference area appears to have been a dryland crop which has been left unmanaged. Google Earth aerial imagery shows the site was managed as cropland until 2004/2006. Prairie dogs have been in the area historically contributing to this reference area degradation.
