INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

In accordance with ECOM Rule 911, this form serves as notification for the decommissioning and abandonment of the Fassler 1-28 produced water pits. Soil and groundwater (if present) samples will be collected and submitted for laboratory analysis to determine if concentrations and values are in compliance with CECMC Table 915-1. Visual inspection and field screening of soils around the produced water pits will be conducted during sampling activities. Soil vapor (PID) screening will also be performed.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

A minimum of five confirmation soil samples- one from the pit bottom and one from each sidewall of each pit- shall be collected and submitted to a NELAP-accredited laboratory for the full Table 915-1 analysis. Additionally, three background soil samples will be collected from similar depths and soil horizons as confirmation soil samples and submitted for Table 915-1 analyses.

Proposed Groundwater Sampling

Will groundwater samples be collected as part of this investigation? (Number, analyses, and locations of samples):

If groundwater is encountered during facility decommissioning activities, a minimum of one grab sample will be collected as soon as practical. Groundwater samples will be submitted to a NELAP-accredited laboratory for analysis of benzene, toluene, ethylbenzene, total xylenes (BTEX), naphthalene, 1,2,4-TMB, and 1,3,5-TMB using standard methods appropriate for detecting the target analytes in CECMC Table 915-1.
