Describe what is known about the spill/release event (what happened -- including how it was stopped, contained, and recovered):

On 3/27/2025, HANSCOME C21-20 flowline decommissioning activities were completed. During the completion of the activities, no potential presence of impacted material(s) was observed/smelled. Consistent with Rule 912, samples were collected and analyzed to determine whether any constituents are present at levels in excess of Table 915-1 standards. Final laboratory analytical results received on 4/10/2025 indicate that soil sample FL01-01, discovered along the flowline, exceeded ECMC Table 915 standards for naphthalene at 0.0771 mg/kg, benzo(a)anthracene at 0.309 mg/kg, benzo(a)pyrene at 0.215 mg/kg, benzo(b)fluoranthene at 0.308 mg/kg, 1-methylnaphthalene at 0.0154 mg/kg, and 2-methylnaphthalene at 0.0265 mg/kg. Groundwater was not encountered during flowline decommissioning activities.
