On 3/27/2025, HANSCOME C21-20 flowline decommissioning activities were completed. During the completion of the activities, no potential presence of impacted material(s) was observed/smelled. Final laboratory analytical results received on 4/10/2025 indicate that soil sample FL01-02, discovered along the flowline, exceeded ECMC Table 915 standards for naphthalene at 2.74 mg/kg, TPH at 1499.104 mg/kg, acenaphthene at 5.01 mg/kg, anthracene at 6.81 mg/kg, benzo(a)anthracene at 9.56 mg/kg, benzo(a)pyrene at 6.49 mg/kg, benzo(b)fluoranthene at 10.0 mg/kg, benzo(k)fluoranthene at 3.54 mg/kg, dibenzo(a,h)anthracene at 1.43 mg/kg, fluoranthene at 28.5 mg/kg, fluorene at 5.76 mg/kg, indeno(1,2,3-cd)pyrene at 4.14 mg/kg, pyrene at 20.7 mg/kg, 1-methylnaphthalene at 0.578 mg/kg, and 2-methylnaphthalene at 1.01 mg/kg. Groundwater was not encountered during flowline decommissioning activities.
