## COMMENTS:

TEP Rocky Mountain LLC (TEP) is submitting this Form 4 to satisfy a Condition of Approval (COA) attached to ECMC Document # 403772861. The COA states "No later than 03/16/2025, conduct a bradenhead test, submit a Form 17, and submit a Form 4 Sundry that summarizes current well condition. The well should be shut in for seven days to monitor and collect data to characterize build up pressures prior to conducting the bradenhead test. The sundry should include details of the future plans, sample analysis interpretation, bradenhead test description, and the flow rate information and pressure data." An annual bradenhead test, which included a seven-day shut-in of the bradenhead connection to the sales line, was performed on March 4, 2025, and the Form 17 reporting the results of this test can be referenced under ECMC Document # 404119338.

The bradenhead connection to the sales line is effectively managing the bradenhead pressure and maintaining a consistent bradenhead pressure below the calculated threshold pressure of 92 psi. TEP has included the historical monthly pressure data as an attachment.

Per ECMC Operator Guidance, the following lines of evidence demonstrate conclusively that the Knight W-6-4 has both casing integrity and wellbore isolation:

- During the recent bradenhead test, the bradenhead pressure decreased to 0 psi in less than ten minutes with a de minimis volume of gas. The production casing maintained a pressure 95 psi throughout the thirty-minute bradenhead test.
- The analytical results of the recent bradenhead and production gas samples have been submitted to the ECMC via a Form 43 (404119315). The Knight W-6-4 is a Wasatch G producer and it is expected that the analytical results of the bradenhead gas and production gas would be similar.
- After reviewing the drilling and completions reports, TEP identified multiple cement squeezes within the production casing annulus. TEP does not have access to a cement bond log for this well. TEP provided ECMC an updated the wellbore diagram in September 2024 to reflect the both the drilling and completion reports.

TEP will continue to utilize the Knight W-6-4 bradenhead connection to the sales line to effectively manage the bradenhead pressure below the calculated threshold pressure as detailed in the ECMC approved Pressure Management Plan. TEP will also continue to monitor the bradenhead pressures as part of our monthly monitoring and annual testing programs and will report any future bradenhead threshold pressure exceedances as required by Rule.

1. Operator will implement measures to control venting, to protect health and safety, and to ensure that vapors and odors from well operations do not constitute a nuisance or hazard to public welfare.
2. Bradenhead gas is not to be vented to the atmosphere; any gas from the Bradenhead will be routed to a specified abatement system. Shut in bradenhead pressure shall not exceed threshold pressure. Operator will implement measures to get an estimate of the gas flow rate and/or volume from the bradenhead.
3. No later than 03/04/2026, conduct a bradenhead test, submit a Form 17, and submit a Form 4 Sundry that summarizes current well condition. The well should be shut in for seven days to monitor and collect data to characterize build up pressures prior to conducting the bradenhead test. The sundry should include details of the future plans, sample analysis interpretation, bradenhead test description, and the flow rate information and pressure data.
4. If a sample has not been collected from surface casing within the last twelve months collect bradenhead gas samples for laboratory analysis. Sampling will comply with Operator Guidance - Bradenhead Testing and Reporting Instructions, Appendix A: Liquid and Gas Sampling. Copies of all final laboratory analytical results will be provided to the ECMC within three months of collecting the samples.
