Conducted an on-site inspection/audit at QB ENERGY OPERATING LLC N. PARACHUTE WF I25 596 Pad

Location # 335590 in Garfield County Colorado.

Location is within High Priority/Density/NSO/Black Bear Habitat areas.

Location is within Rule 411b Generalized Internal Buffer.

Location is approximately 78 yards from Middle Fork Parachute Creek.

Location is approximately 371 yards from West Fork Parachute Creek.

While there, I observed normal production operations.

During this inspection/audit the following compliance issues were observed:

1. Equipment - Unused flowline does not comply with CECMC rules with a CA date of 6/12/2025

2. Inspected Facilities - Multiple wells lack wellbore diagrams/not in compliance with CECMC rules with a CA date of 07/05/2025
