General Comment:**CECMC Inspection/Audit Report Summary**

On 06/17/2025 at approximately 11:50 hours, Compliance Inspector Dusty Popejoy conducted an on-site inspection/audit at QB ENERGY OPERATING LLC NOLTE 14-44 PAD at Location ID #334568 in Garfield County, Colorado.

This location is within or in close proximity to, a CPW Density/High Priority Habitat, Black Bear, NSO Habitat, or Wildlife Management area & Bald Eagle Roost Site.

Location is a shared location with TEP ROCKY MOUNTAIN LLC.

During the inspection/audit, the following compliance issues were observed:

1. Equipment - Multiple flow line heating insulation open ended/wildlife hazard available for entry by wildlife with a CA date of 06/26/2025
2. Inspected Facilities - NOLTE #14-44 well lacks wellbore diagram/not in compliance with CECMC rules with a CA date of 07/19/2025
3. Signs/Marker - Wellhead lacks signage/not in compliance with CECMC rules with a CA date of 07/19/2025
4. Signs/Marker - Battery signage is not legible/not in compliance with CECMC rules with a CA date of 07/19/2025

A follow-up on this site inspection/audit will be conducted to ensure the compliance issues have been corrected to comply with CECMC rules.
