The well is partially located within a fallow field. The location and access road appears to have been decompacted. Undesirable weed kochia is present on location. Large cobble is present on location. The non-cropland portion of the location appears to have established desirable perennial vegetation. See attached pictures.

Corrective Action: **Remove cobble. Continue to monitor and manage this location. Perform additional reclamation as required. An inspection will be conducted during and active crop growing season in the future.**
