The road/flowline trench area, which have minimal vegetation, were not planted by the farmer in the Spring of 2024 as the flowline trench was open (waiting on final approval of the Form 27 prior to closure). This area will be planted in the future and should have normal vegetation. PADCO requests these areas get re-inspected in late Spring 2026. |  |                                       |

If the ECMC still has concerns, PADCO would request a site visit in late Spring 2026 (per the landowner/farmer).<br><br>PADCO submitted the applicable Form 44 on May 14, 2024 but it is still "in process" with the ECMC. Per the landowner, the lack of vegetation in the areas indicated by the inspector are due to them "not planting" where the historic road/flowline was and due to a herbicide application done by the farmer in the area of minimal growth. Landowner expects normal soil growth by Spring 2026. |
