The overall status for the reclamation of the Location is "in process". Vegetation over the majority of the Location appears to be progressing towards 1004 standards.

Records show well was PA 9/1/2023. Pursuant to 1004.a, all surface equipment is required to be removed within 3 months of plugging a well. Pipe riser and other surface equipment observed on the north end of the Location; equipment was required to be removed by 12/1/2023.

Corrective Action: **Comply with 1004 Rules and remove surface equipment remaining on the Location.**
