Comment: A historical release was discovered 01/23/2025 during Remediation Project 23824 and the Form 19 Initial with Supplemental Report (Doc # 404069440) was received on 01/24/2025. Pursuant to Rule 912.b.(6) Operator was required to submit a Form 19 Supplemental Report for the associated spill within 90 days of the spill date requesting closure that was due 04/24/2025 and is 63 days late. Operator shall submit and request closure of the Form 19 by checking the box for "Work proceeding under an approved Form 27 (Rule 912.c)" and submit a Supplemental Form 27 for this project within 14 days. Operator is out of compliance with Rule 913.e.(3). Quarterly reporting (90 days) is required under Remediation Project #23824. Operator is past due on quarterly reporting. The last Form 27 was received on 01/21/2025 (Doc # 404060418) and denied by ECMC with comment, "Operator states " Please note that laboratory detection limits for several organic constituents in the attached Eagle Site Investigation Report are listed as 0.020 milligrams per kilogram (mg/kg) and 0.005 mg/kg for WH-FS-01@6 ' whereas the laboratory report lists detection limits of 0.0067 mg/kg" ECMC has denied this form as it is not appropriate to enter errors into the official record. In accordance with Rule 207 Operator shall conduct a full QAQC review and submit a complete and accurate report."
