Comment:

Pursuant to Form 4 records (e.g. Doc. No: 402462801), the permitted wells on the Location have been abandoned and not drilled; additionally, sundry records state that the Location has not been constructed, and is also abandoned.

It was observed during this inspection, that the Location was not constructed and meets Final Reclamation Standards. However, it was observed that "stakes/poles" were left on the Location.

Corrective Action:

Comply with Rule 1004.a., Remove all debris. Submit a Form 4 sundry with photo evidence showing removal of debris.
